

Introductory Provisions

These Operating Rules set out the conditions for the use of the public Grillpoint located in Budoucnost Park in Havlíčkův Brod (2 public barbecue sites). Their purpose is to ensure safe operation, protect the health of visitors, safeguard property, and maintain cleanliness and order.

The barbecue sites are intended for use by the general public on a first-come, first-served basis. Barbecuing supplies are not provided as part of the facilities (including firewood, charcoal, briquettes, or grilling utensils).

By entering the Grillpoint area, the user confirms that they have read and understood these Operating Rules. No prior registration or reservation is required to use the barbecue sites.

The operator is Technické služby Havlíčkův Brod, Na Valech 3523, Company ID No. 701 88 041.

Rules of Use

- Before starting a barbecue, the user must report the intended use via the QR code or SMS.
- Fire may only be lit in the grill firebox. The firebox must be prepared by the arriving user.
- Only dry firewood, charcoal, or charcoal briquettes brought by the user may be used in the grill. No fire accelerants or supporting substances may be used.
- Persons under 18 years of age may use the barbecue site only under the supervision of a person over 18 years of age.
- The maximum capacity of one barbecue site is 15 persons.
- The size and intensity of the fire must be adjusted to the current weather conditions to prevent it from spreading beyond the grill area.
- The barbecue sites may be used daily from 8:00 a.m. to 10:00 p.m.
- After finishing the barbecue, the user is required to ensure that the fire is completely extinguished so that it cannot reignite. The user is also responsible for thoroughly cleaning the barbecue site. Extinguished ash must be left in the firebox.
- In the event of a fire, every person is obliged to attempt to extinguish it using available means. If the fire cannot be safely extinguished, the user must immediately contact the Fire Rescue Service by calling 150 or 112.
- In the event of extraordinary weather conditions (e.g. prolonged drought or strong winds), the operation of the barbecue sites may be temporarily suspended.

Prohibited Activities

It is prohibited to:

- light fires outside the barbecue facilities;
- damage the equipment or site furniture;
- burn waste, plastics, or other unsuitable materials;
- leave a fire unattended;
- damage or litter the barbecue site and its surroundings;
- dispose of hot or non-cooled ash outside the designated area;
- camp or set up tents;
- use pyrotechnic products;
- play music at a volume that disturbs other visitors to the park;
- organize commercial events.

All visitors use the barbecue sites and their surroundings at their own risk and responsibility. The operator shall not be liable for any damage to health or property resulting from improper use of the barbecue sites, nor for the loss of or damage to visitors' personal belongings.

Any damage to or contamination of the barbecue site must be reported to the operator without delay.

The operator is entitled to terminate the use of the Grillpoint by persons who violate these Operating Rules or whose conduct endangers the safety of other visitors.

These Operating Rules were approved by the City Council of Havlíčkův Brod on **13 July 2026** by **Resolution No. 521/26**.
